GENERAL INFORMATION AND CONDITIONS OF ENTRY: (Please READ CAREFULLY)

- Entries are pre-paid and made in progressive payments. *Payments will only be accepted on the Payment Form provided.* Forms may be photo-copied if insufficient space.
- Owners of the nominated horse/s **MUST** be current NSWPHA members by the FOURTH (final) payment. All Handlers or riders **MUST** be current NSWPHA members to compete in the futurities.
- Except where otherwise stated, all NSWPHA Futurity events are open to any horse of the correct age registered with the PHAA. Except where otherwise stated, all horses entered in the futurity events must be registered in either the PHAA regular registry or Paint Bred registry.
- Copies of PHAA registration** certificates are to be submitted by the FOURTH (final) payment.
- Both Sire and Dam must be registered with an acceptable association at the time of nomination. No 'pending' registrations for sire or dam will be accepted. One or both parents must be registered in either the PHAA regular registry or Paint Bred registry.
- Weanling Futurity** – weanlings must have their mare (dams) nominated prior to the 1st August of the foaling year – **no late nominations accepted.**
- Minimum number of entries FOR ALL FUTURITES is THREE (3). The NSWPHA Committee has the right to cancel any event and will refund any monies less an office fee should there be insufficient entries by the FOURTH (final) payment. Entrants will be advised of any such cancellation.

8. **Refunds** – no refunds after the due dates are given for any reason (excepting the above No.7).
9. **Substitutions** – Only ridden horses may be substituted on receipt of notice of disablement or death, each case is then considered on its merits by the NSWPHA Committee. A penalty fee of 50% of the total payment applies to any substitution. A horse can only be submitted in the same event and by a horse belonging to the same owner.
10. **Buy-ins** are permitted on all futurities **WITH THE EXCEPTION OF THE WEANLING FUTURITY** at double the Nomination Fee and double normal outstanding payments. Subsequent payments are at the normal cost.
11. **Payments** – are to be received by the due date. Postmarks are checked for post date. A late fee, as shown, will be charged on payments received after the due date. Late **FINAL** (fourth) payments will be charged at **TRIPLE** the amount due and must be received by the Futurity Co-ordinator **PRIOR** to the commencement of the Show.
12. **Incorrect Paperwork** – an Office Fee of \$10.00 may be charged for incorrect or incomplete documentation. Incorrect/incomplete documentation will be returned for correction/completion and must be resent to the Futurity Co-ordinator **BEFORE** the next due payment date with additional office fee included.
13. **Cheques** – any cheques returned / dishonoured by the bank will be charged to the entrant plus all bank fees plus a \$25 handling fee. **Postdated Cheques** – will **NOT** be accepted.
14. **Protests** – under current HSAA rule procedure – all protests **MUST** be accompanied by a \$100 fee which is refundable if the protest is upheld. Any protest **MUST** be lodged within one hour of the completion of the class. Competitors/exhibitors in the event, or any show official may lodge a protest. See HSAA Rule 65.
15. **Drug Testing** – may be done on any event and will be done at random. There must be an announcement prior to the class informing competitors that drug testing will be carried out on a horse or horses in that class. The drug steward must accompany the horse from the ring to the testing box. The horse is not to be left unsupervised, the drug steward must remain with the horse until the Veterinarian has completed the testing procedure and all paperwork has been completed and signed. The drug steward must have NSWPHA authority to sign any relevant paperwork. The owner/handler of the horse should appoint a representative to also accompany the horse. Prizemoney is to be withheld until such time as a clear/negative test result is received by the NSWPHA.

PRIZEMONEY, PRIZES, ETC

1. **Prizemoney** – is to be calculated prior to the show and consists of total income from nomination/payments less expenses.
 - 1.1. Prizemoney is paid by cheque from the NSWPHA Futurity Account, and is made payable to the recorded owner of the horse.
 - 1.2. Prizemoney payouts are on a sliding scale and calculated according to the number of entries and paid to the nearest dollar.

Exception – The NSWPHA Committee reserves the right to allow provision to re-allocate a percentage of prizemoney within a futurity to offer incentives to the competitors in that event.

- 1.3. In the event that horses fail to finish and qualify for a placing, the prizemoney payout shall be calculated on the number of horses that finish and qualify for a placing. In the event that no horses finish and qualify for a placing all moneys less expenses shall carry over to the same event in the next years futurity.
2. **Expenses** –are calculated by dividing the total expenses by the total number of horses in all futurities. This figure is then multiplied by the number of horses fully paid up or each event to calculate the expenses for that event.

- Buy ins are able to enter into a futurity (other than weanling futurity) after the due date of any payment up to the final payment due date, but no later than final due date. However the late nomination fee will be double; a fee of 50% of the outstanding payments will be charged for buy-ins and subsequent payments will be at the normal cost.
- Late 4th payments will be charged at TRIPLE the payment.
